DATA PRIVACY DECLARATION BY PIEPS

PIEPS GmbH (in the following briefly referred to as PIEPS or "we") attaches great importance to the safety and protection of your personal data. 2. COMMUNICATION OR USE DATA

- 2.1 By using telecommunication services to access our web site, communication services data (e.g. the IP address) or use data (e.g. information on the beginning, end and scope of the use in question and information on the telecommunication services used) will be generated automatically by technical means and might refer to personal data. Your communication and use data will be recorded, processed and used to the extent absolutely necessary, however, only in conformity with the applicable data protection laws.
- 2.2 Whenever you use our web site, we may automatically record (i.e., even without registration) non-personal data (e.g. the type of the internet browser used and the operating system, domain name of the web site that you last visited, number of visitors, average duration of your visit, the pages visited). We use these data in order to determine the attractiveness of our web site and to improve its performance and contents.

2.3 This website uses Google Analytics, a web analytics service provided by Google, Inc. (in the following briefly referred to as Google) in order to improve and optimize the web site. Google Analytics uses "cookies", which are text files placed on your computer, to help the website analyze how users use the site.

The information generated by the cookie about your use of this web site will be transmitted to and stored by Google on servers in the United States. We use " anonymizelp()" on the website. Using this extension, the IP addresses are processed shortened exclude in form in order to direct personal reference. By making the IP address on the web site anonymous, your IP address will first be shortened by Google in a member state of the European Union or in a contracting state to the agreement on the European Economic Area. Only in exceptional cases will the entire IP address be sent to the Google server in the USA and shortened there. By using Google Analytics for the data recorded on the web site, Google as the service provider will process the data for us in order to exploit the use of the web site by you, to arrange reports for the web site activities for us and to provide us with further services associated with the use of the web site and internet use. By using this website, you consent to the processing of data about you by Google in the manner and for the purposes set out above.

You may refuse the placing of cookies by selecting the appropriate deactivation settings in your browser software, however, please note that if you do this you may not be able to use the full functionality of this website.
